- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

3. This privacy policy applies only to the actions of JRT Decorating Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data collected

4. We may collect the following Data, which includes personal Data, from you: a. Name

## Our use of Data

- 5. For purposes of the Data Protection Act 1998, JRT Decorating Limited is the "data controller".
- 6. We will retain any Data you submit for 6 months.
- 7. Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and / or other companies within our group.
- 8. All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see the clause below (**Security**).
- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons: a. internal record keeping; in each case, in accordance with this privacy policy.

## Third party websites and services

10. JRT Decorating Limited may, from time to time, employ the services of other parties for dealing with certain processes necessary for the operation of the Website. The providers of such services do not have access to certain personal Data provided by Users of this Website.

# Changes of business ownership and control

Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.

- 13. We may also disclose Data to a prospective purchaser of our business or any part of it.
- 14. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

# Controlling use of your Data

- 15. Wherever you are required to submit Data, you will be given options to restrict our use of that Data. This may include the following:
- 16. use of Data for direct marketing purposes; and
- 17. sharing Data with third parties.

- 33. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 34. This privacy policy is governed by and interpreted according to English law. All disputes arising under this privacy policy are subject to the exclusive jurisdiction of the English courts.
